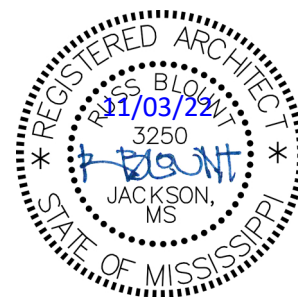

1.2 NOTICE TO BIDDERS

- A. This Addendum is issued to all registered plan holders pursuant to the Instructions to Bidders and Conditions of the Contract. This Addendum serves to clarify, revise, and supersede information in the Project Manual, Drawings, and previously issued Addenda. Portions of the Addendum affecting the Contract Documents will be incorporated into the Contract by enumeration of the Addendum in the Owner/Contractor Agreement.
- B. The Bidder shall acknowledge receipt of this Addendum in the appropriate space on the Bid Form.
- C. The date for receipt of bids is **UNCHANGED** by this Addendum at same time and location.

1.3 GENERAL RESPONSES TO REQUESTS FOR INFORMATION

- A. QUESTION: Would you consider allowing additional time? Delivery times for equipment continues to be a problem with all projects at present.

ANSWER: Yes, we will allow an extension with this project. The new completion date will be August 1, 2024.

- B. QUESTION: Would you clarify the status of being able to work during school hours? Some schools are allowing contractors two classrooms or so at a time so work can continue during normal work hours. Your assistance is appreciated.

ANSWER: Yes, Contractor will be allowed to work during normal school hours except during testing. Due to the lack of classroom spaces, the School District is limited to providing complete access to classrooms during normal school hours. Coordination with Principal will be provided to accommodate the Contractor as possible.
